Rules and Regulations for testing Facility

1. No sample will be analyzed without advance payment.
2. **Nationalize Bank Demand Draft / Cheque at par will be accepted in Favour of "SAIF PHARMA", payable at Rajkot and send it to above mention address.**
3. **50% Discount for Academic Institute and 75% Discount for Student and Research scholar of Saurashtra University Campus.**
4. All concern person, research fellows and students are advised to send their application and sample through **supervisor or head of department**. The request must be made only on **University/College letter Head/Pad**.
5. Samples and payment should be sent preferably in the same cover. Separate sample should be sent for different analysis.
6. The sample **name/batch no./ Required analysis** should be clearly mentioned on sample/requisition form.
7. Sample preparation and method development will be charged extra, varies from material to material and method to method depending on the sample, if required so. Charges will be quoted on a case to case basis.
8. The analytical data/ spectra are provided only for research/ development purposes. These cannot be used as certificates in **legal disputes**.
9. Radioactive Material should be clearly mentioned and handed over personally.
10. Unstable and explosive compounds are not accepted for analysis.
11. Interpretation of results is not undertaken normally.
